The DeKalb County Commission met in regular session on Tuesday September 12, 2017 at 10:00 a.m. in the DeKalb County Activities Building (Courthouse Annex). Those present were Ricky Harcrow, President, Shane Wootten, Scot Westbrook, Chris Kuykendall, and Dewitt Jackson.

The meeting was called to order by President Harcrow and delivered the invocation and Mr. Westbrook lead the Pledge.

It was moved by Mr. Wootten, seconded by Mr. Kuykendall all members voting affirmatively, motion carrying to dispense with the reading of the minutes and to accept them as presented in written format.

Road Department

<u>Road Maintenance Update</u>--Mr. Broyles stated that the County was very fortunate that we had not sustained damage from the aftermath of Hurricane Irma. Mr. Broyles told the Commission that crews had completed most of the work on the Buck's Pocket.

Mr. Wootten stated that he had received calls asking about when work would be done on many of the roads in his District. Mr. Wootten read a list of 16 County Roads that included County Roads 608, 712, 803, 228, 727, 764, 611, 721, 754, 775, 725, 719, 815, 783, 371, 222, and 664. Mr. Wootten stated that these roads are on the patch truck list for repair, but it would take the rest of the year to complete, therefore, if there is a road in the county not currently on this list it will most likely not be repaired this year. Mr. Wootten told the audience that the County had not received an increase in funding from the state for road repairs in many years, and that citizens should contact Legislators and Representatives to request additional funding. Mr. Wootten noted that Representative Ledbetter and Senator Livingston had been very helpful to our County and we are very thankful for that.

Engineering

<u>Public Hearing</u>--Mr. Luther presented a Petition to Vacate a portion of County Road 9 from the property owner. Mr. Luther requested the Commission open the floor to anyone who may be opposed to this vacation. With no one in opposition to this road vacation, Mr. Luther presented a resolution to grant permission to vacate this portion of County Road 9.

Mr. Westbrook made a motion to adopt the following resolution, with a second from Mr. Wootten, all members voting affirmatively, motion carried to vacate a portion of County Road 9:

WHEREAS, the DeKalb County Commission has intent to apply for grant funding from the Alabama Department of Economic and Community Affairs (ADECA) for a 2017 Community Development Block Grant (CDBG) to repair/resurface roads in an area containing a population, the majority of which meets HUD low-to-moderate income status definitions; and

WHEREAS, these grants require the conducting of a Four Factors Analysis of the area Population's socio-ethnic and language fluency characteristics to determine if there are a significant number of persons present with Limited English Proficiency (LEP) such that the development and adoption of a Language Access Plan (LAP) to insure their ability to participate in HUD/CDBG programs is required; and

WHEREAS, the Commission has used ADECA's Four Factors Analysis guidelines and performed that LEP analysis, and determined that, a threshold exists such that the development and adoption of a LAP is required; and

WHEREAS, the Commission has, based on local knowledge and resources, and ADECA guidelines, developed and enumerated a Language Access Plan as a part of the process; Now, therefore, the DeKalb County Commission does hereby adopt the ADECA guideline derived LAP prepared from its Four Factor Analysis of the Limited English Proficiency status of DeKalb County. This statistical base of this LAP shall updated as appropriate, and shall serve as the guide to the Commission in the development, implementation and execution of its Community Development Block Grant program.

This RESOLUTION is PASSED, ADOPTED and APPROVED, this, the 12th day of September, 2017.
