The DeKalb County Commission met in regular session on Tuesday October 24, 2017 at 10:00 a.m. in the DeKalb County Activities Building (Courthouse Annex). Those present were President Ricky Harcrow and Commissioners Shane Wootten, Scot Westbrook, Chris Kuykendall, and Dewitt Jackson.

The meeting was called to order by President Harcrow and Mr. Wootten delivered the invocation and Mr. Kuykendall lead the Pledge.

President Harcrow extended the Commission's condolences to Mr. Jackson and his family on the passing of his father.

It was moved by Mr. Wootten, seconded by Mr. Westbrook, all members voting affirmatively, motion carrying to dispense with the reading of the minutes and to accept them as presented in written format.

Road Department

<u>Road Maintenance Update</u>--Mr. Broyles stated that they had received the Excavator that was approved to purchase at the previous meeting and would start using it as soon as the buckets were installed. Chert is not being hauled this week due to the rain, instead crews are patching potholes.

Engineering

<u>Boozer Road Bridge Project</u>-- Mr. Luther stated that the City of Rainsville has an ATRIP project for a bridge replacement on Boozer Road and the city has requested the County provide backfill to tie the bridge back into the road on each side. In exchange the City of Rainsville will deed 2 acres of property on Star Road that could become the District 4 meeting site for the Road Department Crew.

Mr. Jackson made a motion that the Commission approve this project, with a second from Mr. Kuykendall, all members voting affirmatively, motion carried.

SR 114 Bridge Project--Mr. Luther presented a resolution from the State DOT to provide access to our roads to complete the work on at bridge on SR 114. Mr. Luther stated that once work is complete on this new bridge the old bridge would become a pedestrian walking bridge. Mr. Wootten made a motion to give President Harcrow authorization to sign the following resolution granting access to ALDOT for this project, with a second from Mr. Westbrook, all members voting affirmatively, motion carried:

Inmate Medicaid Resolution/Agreement--Mr. Sharp stated the in the 2017 Legislative Session the Legislator passed a law which would authorize counties to participate in what is called a Medicaid for County Inmates Program. Mr. Sharp explained that it was his understanding that inmates currently on Medicaid had their benefits terminated once they were incarcerated causing the Counties to pay for the medical costs of these inmates at a much higher rate than would be if the inmate were still on Medicaid. This legislation would not terminate the benefits, but would suspend them until the inmate had a medical necessity that required 24 hours of outside medical care. The ACCA is coordinating this program and asked each County that wanted to participate to adopt a Resolution authorizing an agreement to participate.

Mr. Jackson made a motion to adopt the following joint resolution with the Sheriff to participate in the Medicaid for County Inmates Program, with a second from Mr. Westbrook, all members voting affirmatively, motion carried.

JOINT RESOLUTION TO PARTICIPATE IN THE MEDICAID FOR COUNTY INMATES PROGRAM

No. 17-1024-02

WHEREAS, Act 2017-298 authorizes a county to participate in the Medicaid for County Inmates Program (hereinafter the "Program") established and operated pursuant to that law to enable a county inmate to have his or her Medicaid benefits suspended, but not terminated provided he or she is otherwise eligible for Medicaid benefits; and

WHEREAS, Act 2017-298 authorizes a county to participate in the Medicaid for County Inmates Program (hereinafter the "Program") established and operated pursuant to that law to enable a county inmate to have his or her Medicaid benefits for medical care received as an inpatient in a medical institution reinstated provided he or she is otherwise eligible for Medicaid benefits; and

WHEREAS, Act 2017-298 requires a participating county to engage in a process to identify county inmates who are Medicaid recipients at the time they are taken into custody; and

WHEREAS, Act 2017-298 requires a participating county to engage in a process to notify the Alabama Medicaid Agency when the Medicaid benefits of a county inmate are due to be reinstated for inpatient services because the county inmate is receiving inpatient care in a medical institution; and

WHEREAS, Act 2017-298 requires a participating county to engage in a process to reimburse the Alabama Medicaid Agency for the full amount of any federally required state match due for the inpatient services provided to a county inmate whose Medicaid benefits for inpatient services are reinstate under the Act; and

WHEREAS, Act 2017-298 requires a participating county to engage in a process to notify the Alabama Medicaid Agency when the county inmate is no longer an inmate of a public institution under the administrative control and responsibility of the county sheriff; and

WHEREAS, pursuant to Act 2017-298, the Association of County Commissions of Alabama (the "Association") and the Alabama Medicaid Agency shall develop, approve, and implement a centralized process for dissemination of information between the Medicaid Agency and the counties; and

WHEREAS, pursuant to Act 2017-298, the Association is authorized to provide information to the Alabama Medicaid Agency on behalf of the counties;

WHEREAS, the Association and the Alabama Medicaid Agency have developed a Program which complies with the requirements of Act 2017-298 whereby the Association will submit reports to Medicaid on behalf of counties that have executed a participation agreement and business associate agreement with the Association, which agreements sets out the procedures for report submissions; and

WHEREAS, the DeKalb County Commission and County Sheriff each desires to participate in the Program pursuant to Act 2017-298; and

WHEREAS, the ability to have Medicaid benefits reinstated county inmates to cover instances of inpatient medical services for otherwise eligible Medicaid beneficiaries should result in cost savings to the county;
