<u>Training</u>—Mr. Sharp on behalf of Leslie Ledbetter, requested Sarah Gulledge to attend a certified Euthanasia Tech Training Course on March 28 & 29 in Birmingham.

Mr. Westbrook made a motion approve the training, with a second from Mr. Black, all members voting affirmatively, motion carried.

NOTE: This a 100% Federal Grant up to \$37,250, so this grant would purchase up to 40 AED's at the low bid of \$918.25 from The EMS Super Store
