Mr. Clifton made an announcement to the Commission and audience of approximately \$103K that has been awarded to the county for emergency operation upgrades and for the Sheriff's Office for specialized upgrades. He commended Mr. Posey for his efforts in obtaining these grants.

President Harcrow notified the audience that the next meeting will be October 13, 2020 and asked for a motion to adjourn.

Mr. Westbrook made a motion to adjourn. The President declared no objections and ordered the meeting adjourned.
