Project Nos. 40-42 were added September 8, 2020. Project Nos. 39-42 do not utilize Rebuild funds but are listed for the purpose of showing the County's total BST paving plan. Project Nos. 43-44 were added first of October, No RA funds used, plan not amended. Project No. 31, CR-6, paving limits were extended, but plan not amended. Due to unforeseen circumstances and continual maintenance issues, CR-228 was not able to be prepared for paving. Therefore, Project No. 5 was changed on May 27, 2021 to CR-775, with a similar treatment type. Actual CRAF funds received exceeded estimated funds by \$61,770.10. Additional funds reallocated to other projects within the plan. Project Nos. 8, 9, 10, 31, 35 & 40 were not able to be completed by the contractor. These projects 'CRAF funds were reallocated to other projects within the plan. Project Nos. 39-44 had no CRAF funds allocated to them originally. Some of the reallocated funds were applied to Project Nos. 41 & 42. Remarks
