<u>Award CR 102 - CR147 – Town of Ider Resurfacing Bids</u>—Mr. Luther addressed the Commission stating that bids were opened on June 20, 2024 for widening and resurfacing **CR 102** from CR47 to SR75 in Sylvania (Project# RA-DCP-D25-01-2024). Two bids were presented from Rogers Group for \$1,092,600.00 and Wiregrass Construction for \$1,187,719.87. Mr. Luther made the recommendation to award the bid to Rogers Group, Inc.

Mr. Luther also presented a bid proposal opened on July 8, 2024 for Resurfacing on **CR147** from CR141 to CR 732 and also **Dogwood Drive** in the Town of Ider. (Project # ST-025-888-023). He made the recommendation to award the project to Rogers Group who had the lowest bid of \$523,700. (One other bid was received from Wiregrass Construction for \$617,809.90). The Town of Ider will be assisting with funds for this project.

Mr. Wootten made a motion to accept County Engineer Ben Luther's recommendation of both projects. Mr. Black seconded the motion. All members voting affirmatively, motion carried (including the adoption of a required resolution to utilize unused D4 ARPA water project funding for the CR 102 Project):

## **RESOLUTION No. 24-0709-02** FOR THE EXPENDITURE OF AMERICAN RESCUE PLAN ACT REVENUE REPLACEMENT FUNDS FOR GOVERNMENT SERVICES CR 102 Project - District 4

WHEREAS, DeKalb County, Alabama, (the "County") has received an award of Coronavirus State and Local Fiscal Recovery Funds under the American Rescue Plan Act from the U.S. Department of the Treasury ("Treasury"), \$10,000,000 of which have been duly designated as revenue replacement funds ("ARPA revenue replacement funds") in accordance with the final rule issued by Treasury on January 6, 2022 (the "final rule"); and

WHEREAS, the DeKalb County Commission (the "Commission") is charged with ensuring the expenditure of the County's ARPA revenue replacement funds in accordance with state and federal law;

WHEREAS, ARPA revenue replacement funds may be used for the purpose of providing government services, including costs that the County typically bears to provide these services to its citizenny; and

WHEREAS, these costs include the cost of constructing and maintaining County roads and bridges ("public roadways"); and

WHEREAS, in accordance with the provisions of the final rule and related guidance issued by Treasury, the County may use ARPA revenue replacement funds for pay-go funded road construction and maintenance; and

WHEREAS, the Commission desires to conditionally allocate a portion of the County's ARPA revenue replacement funds for use to cover a portion of the reasonable and necessary cost of construction and maintenance of its public roadways to ensure that they are maintained in a safe and operable condition.

#### YOW, THEREFORE, BE IT RESOLVED BY THE COMMISSION as follows:

- 1. The Commission hereby conditionally allocates up to \$362,770 of the County's ARPA revenue replacement funds for resurfacing and associated road construction costs to resurface CR 102 from CR 47 to Hwy 75 near Sylvania in District 4.
- Expenditure of these funds shall be conditioned upon compliance with state laws and guidalines. related to the procurement of goods and services, including compliance the Public Works Law, codified as Title 39 of the Code of Alabama 1975 and the Competitive Bid Law, codified as §§ 41-16-50, et seg., Code. of Alabama 1975, as applicable, and any applicable federal law governing the expenditure ARPA revenue replacement funds.
- Notwithstanding any other provision of this Resolution to the contrary, ARPA revenue replacement. funds allocated by this Resolution shall not be used for the following purposes:
  - a) To make deposits into a pension fund;
  - To service debt or replenish rainy day funds;
  - c) To satisfy settlements and judgments; or
  - d) To fund programs, services, or capital expenditures that undermine efforts to stop the spread of COVID-19.
- 4. Expenditure of ARPA revenue replacement funds, as authorized by this Resolution, shall be contingent on the continued appropriation and availability of ARPA revenue replacement funds for this purpose and in no event shall be used for expenditures not obligated by December 31, 2004, and expended by December 31, 2026.

<u>Liquid Calcium Chloride Annual Bid Award</u>—Mr. Luther presented bid tabs opened on June 27, 2024 for the County's Liquid Calcium Chloride Annual Bid and made the recommendation to award the bid to SE Road Treatment. No other bids were received. (Engineer maintains record of these bid files).

Mr. Saferite made a motion to approve. Seconded by Mr. Harris. All members voting affirmatively, motion carried.

Sign Truck Bid Award—Mr. Luther presented bid tabs opened July 8<sup>th</sup> for one (1) 2024 Chevy Silverado 2500HD 4WD Double Cab 162" Work Truck with 8' Royal 98XP Service Body w/Ladder Rack (or equivalent) Sign Truck for the Road Department. He made the recommendation to award the bid for the Sign Truck to Donohoo Chevrolet who presented the only bid at a cost of \$62,264.50.

<u>Traffic Striping Bid Award</u>—Mr. Luther presented a proposal from J.C. Cheek Contractors for Solid Yellow Class 1 Type A Traffic Stripe (double-line striping) at various locations for a total of 44.6 miles at a cost of \$28,990 (\$650/mile).

Mr. Harris made a motion to accept the recommendations for awarding the new Sign Truck to Donohoo Chevrolet and the Traffic Stripe to J C. Cheek Contractors. Mr. Wootten seconded the motion. All members voting affirmatively, motion carried.

<u>Road Vacation—CR 484</u>—Mr. Luther presented a request to adopt a Resolution to vacate the dead-end portion of CR 484 as petitioned by Mr. Wayne Hill, the sole owner of surrounding property. The floor was opened for public comments. There were none.

Mr. Saferite made a motion to honor the request. Mr. Black seconded the motion. All members voting affirmatively, motion carried to pass the following Resolution:

### RESOLUTION NO. 24-0709-01 VACATION OF DEAD-END PORTION OF COUNTY ROAD NO. 484

WHEREAS, Code Section 23-4-2, State of Alabama, 1975, authorized the governing bodies of the counties of Alabama to, upon petition and by resolution, vacate a street, or a portion thereof; and

WHEREAS, the DeKalb County Commission set down for public hearing on July 9, 2024, and caused notice of such hearing to be published in *The Mountain Valley News* for four consecutive weeks, beginning June 6 and running through June 27, 2024; and

WHEREAS, the DeKalb County Commission has received no written objection and heard no verbal objection at the hearing hereon to the vacation of the dead-end portion of County Road 484 as described below; and

WHEREAS, Commissioner Saferite of District III, made a motion before this Commission to approve the vacation of this portion of the road;

THEREFORE, BE IT RESOLVED, by the DeKalb County Commission that the dead-end portion of County Road No. 484, more particularly described below, be, and hereby is, vacated;

All of the dead-end portion of County Road 484 as follows: Commencing at the intersection of the southeasterly right-of-way of County Road 484 (60 foot ROW) and the R7E/R8E line of the USGS Public Land Survey System; thence perpendicular to the centerline of County Road 484 for a point of beginning; thence southwesterly along the centerline of the roadway for approximately 700 feet to the dead end. Said property lying in Section 24, Township 8 South, Range 7 East, located in the Portersville area.

BE IT FURTHER RESOLVED, by the DeKalb County Commission that the name of the owners of the abutting properties who have petitioned vacation of said road is Wayne Hill and there are no other lots or parcels of land which will be cut off from access by the vacation sought; and

IT IS FURTHER RESOLVED, by the DeKalb County Commission that it is in the interest of the public that the above-described portion of the public road be vacated; and

IT IS FURTHER RESOLVED, by the DeKalb County Commission that this resolution shall be filed in the Probate Court of DeKalb County as provided by statute and that notice of this action shall be published once in a newspaper in DeKalb County no later than fourteen (14) days after the date of its adoption.

The program has saved seniors thousands of dollars since its inception 3 years ago.
