Remarks Of the remaining \$137,315.47 in CRAF, \$104,897.61 has been reallocated to four (4) different non-CTP roadways that were part of the overall bid package of likework included with the CTP roadways. The remaining \$32,417.56 is being carried over as the beginning balance for FY2026. The CTP cost underrun is attributed to an overestimation of unit prices for the year.

The remaining \$1,557,282.02 of FAEF is being carried over as the beginning balance for FY2026.
